ASN is actively implementing several key initiatives to support the kidney community, including:


- **Podcast on Executive Orders and ASN's Response** - ASN will release a podcast outlining its response to recent Executive Orders and directives, discussing their impact on kidney care and ASN's advocacy efforts.
- **Dedicated Webpage with Key Advocacy Resources** - ASN is developing a new webpage compiling essential advocacy resources, including letters, statements, and coalition communications. It is very important for me personally to 1) communicate the changes that affect all of us and our patients in real time as well as 2) have a way to channel your understanding, expertise, and engagement in a positive manner for the larger kidney community.
- **Joint Action with Like-Minded Coalitions** - ASN continues to collaborate with coalition partners to amplify concerns and advocate for policies that advance kidney care, research, and education. For example, ASN most recently signed onto letters initiated by [Research!America](#) and the [Ad Hoc Group for Medical Research Funding](#).
- **2025 Legislative and Regulatory Priorities** - ASN's four policy-focused committees (ASN Health Care Justice Committee, Policy and Advocacy Committee, Quality Committee, and Transplant Policy Committee) are responsible for accomplishing the society's legislative and regulatory goals in 2025. These goals focus on starting earlier to prevent, diagnose, and treat kidney diseases; transforming transplant to expand access to the optimal therapy; and accelerating research, discovery, and innovation to advance American kidney health.

- **ASN Annual Spring Hill Day on March 19, 2025** - ASN will interact with key legislators and committees on Capitol Hill, calling for reforms and investments to ensure every American has access to optimal kidney care, including engaging with bipartisan, bicameral Congressional champions of kidney health and transplantation.
- **Ongoing Policy Communications via *ASN Policy Insider*** - ASN will continue providing regular updates on federal policy developments through *ASN Policy Insider*, our monthly policy briefing newsletter.

ASN's commitment to excellence in patient care, scientific advancements, and medical education remains unwavering, and the society will continue to advocate for policies that support people living with kidney diseases, health professionals, and researchers. As ASN President, I thank you for your commitment to kidney health and urge you to stay informed, share your insights, and participate in the discussions and initiatives that are shaping the policies that will impact our field.
